3 AIR QUALITY

3.1 DEPOSITIONAL DUST

All depositional dust sampling locations were in compliance with the rolling annual average limit (4g/m²/month) for the period of May 2019 – April 2020. The maximum annual increase in deposited dust levels are also below the criteria limit of 2g/m²/month. Depositional dust monitoring results are presented in **Table 1**.

3.2 PM₁₀ AND TSP

The 24-hour maximum PM₁₀ particulate matter concentration less than 10 microns (PM₁₀) criterion of 50µg/m³ was not exceeded during April 2020. The total suspended particulate (TSP) and PM₁₀ annual average results were in compliance with the annual average limit for April 2020.

PM₁₀ and TSP monitoring results are presented in **Table 2**.

4 SURFACE WATER QUALITY

Monthly surface water monitoring quality monitoring is undertaken for pH, TSS and oil and grease, results are presented in **Table 3**. There were no discharge events during April 2020. The EPL limits are only applicable during a discharge event, and therefore, do not apply to the results shown in **Table 3**.
