## 3 AIR QUALITY

### 3.1 DEPOSITIONAL DUST

All depositional dust sampling locations were in compliance with the rolling annual average limit (4g/m<sup>2</sup>/month) for the period of May 2020 – April 2021. Depositional dust monitoring results are presented in **Table 1**.

## 3.2 PM<sub>10</sub> AND TSP

The 24-hour maximum PM<sub>10</sub> particulate matter concentration less than 10 microns (PM<sub>10</sub>) criterion of 50µg/m<sup>3</sup> was not exceeded during April 2021. The total suspended particulate (TSP) and PM<sub>10</sub> annual average results were in compliance with the annual average limit for April 2021.

PM<sub>10</sub> and TSP monitoring results are presented in **Table 2**.

## 4 SURFACE WATER QUALITY

Monthly surface water monitoring quality monitoring is undertaken for pH, TSS and oil and grease, results are presented in **Table 3**. There were no discharge events during April 2021. The EPL limits are only applicable during a discharge event, and therefore, do not apply to the results shown in **Table 3**.
