1 INTRODUCTION

Castlereagh Coal owns and operates Invincible Colliery located near Cullen Bullen in the Central West district of New South Wales. This report has been prepared pursuant to Chapter 2, Part 3.5, Condition 66(6) of the *Protection of the Environment operations Act 1997* for the publication of results of monitoring and the NSW Environmental Protection Authority guideline titled *Requirements for publishing pollution monitoring data (2012)*.

3 AIR QUALITY

3.1 DEPOSITIONAL DUST

Depositional dust gauges for the November 2021 monitoring period were collected on the 6 December 2021. All depositional dust sampling locations were in compliance with the annual average limit (4g/m²/month) for the month of November 2021, noting that there was a substantial result at ID-D1 for the month of November 2021 which was related primarily to combustible matter and therefore considered to be representative of a contaminated sample. Maximum annual increase in deposited dust levels are also below the criteria limit of 2 g/m²/month. Depositional dust monitoring results are presented in **Table 1**.

3.2 PM₁₀ AND TSP (HIGH VOLUME AIR SAMPLERS)

Monitoring of particulate concentrations less than ten (10) micrometres (PM₁₀) was undertaken using High Volume Air Sampler (HV01) on a six (6) day, 24 hour run cycle. The total suspended particulate (TSP) concentration was determined from the PM₁₀ concentrations. Annual average concentrations for TSP and PM₁₀ were in compliance with the annual average limit. The 24-hour PM₁₀ concentrations for November did not exceed the 24-hour average maximum allowable limit of 50µg/m³.

PM₁₀ and TSP results for November are presented in **Table 2**.

4 WATER QUALITY

A discharge event is deemed to occur when water leaves the site either through the overflow channel of the Main Dam or as a result of actively pumping water. Water was not observed to be discharging from the Main Dam during the site visit on 3 November 2021. A sample was collected at Discharge Point 2 (EPA Point 2) and from the Main Dam for due diligence purposes only. Water quality results are presented in **Table 3**.
