1 INTRODUCTION

3 AIR QUALITY

3.1 DEPOSITIONAL DUST

All depositional dust sampling locations were in compliance with the rolling annual average limit (4g/m²/month) for the period June 2021 to May 2022. Depositional dust monitoring results are presented in **Table 1**.

3.2 PM₁₀ AND TSP

The 24-hour maximum PM_{10} particulate matter concentration less than 10 microns (PM_{10}) criterion of $50\mu g/m^3$ was not exceeded during May 2022. The total suspended particulate (TSP) and PM_{10} annual average results were in compliance with the annual average limit for May 2022.

PM₁₀ and TSP monitoring results are presented in **Table 2**.

4 SURFACE WATER QUALITY

A discharge event is deemed to occur when water leaves the site either through the overflow channel of either Dam 3 or Dam 4, or as a result of actively pumping water. A discharge event was not observed during the site visit on 24 May 2022; therefore, a sample was not required to be collected at either Dam 3 or Dam 4 (EPA Point 1 and EPA Point 2 respectively). A sample was collected from both Dams for due diligence purposes only. Water quality results are presented in **Table 3**.
