3 AIR QUALITY

3.1 DEPOSITIONAL DUST

All depositional dust sampling locations were in compliance with the rolling annual average limit ($4\text{g}/\text{m}^2/\text{month}$) for the period May 2022 to April 2023. Maximum annual increase in deposited dust levels are also below the criteria limit of $2\text{g}/\text{m}^2/\text{month}$. Depositional dust monitoring results are presented in **Table 1**.

3.2 PM₁₀ AND TSP (HIGH VOLUME AIR SAMPLER)

The 24-hour maximum PM₁₀ particulate matter concentration less than 10 microns (PM₁₀) criterion of 50µg/m³ was not exceeded during April 2023. The total suspended particulate (TSP) and PM₁₀ annual average results were in compliance with the annual average limit for the period May 2022 to April 2023.

PM₁₀ and TSP results for April 2023 are presented in **Table 2**.

4 SURFACE WATER QUALITY

A discharge event is deemed to occur when water leaves the site either through the overflow channel of the Main Dam or as a result of actively pumping water. Water was observed to be discharging from the Main Dam during the site visit on 5 April 2023. A sample was collected at Discharge Point 2 (EPA Point 2). Water quality results are presented in **Table 3**.
