

- Return to mining onsite expected once Invincible mining operations stabilizes



- 1) it is my understanding that complainants should not be named in the publicly available complaints register. However the complaint on the 4th August 2023 clearly states who the complaint was made by. Requested consultant to remove name from website 3/10/2023. New process will be implemented, to eliminated this issue reoccurring. No malice intended with this error.
- 2) the complaint on the 4th August 2023 states that corrective actions were required and that these actions were closed on the 10th August 2023. However the complainant has informed me that no actions has been undertaken to this date. Can you confirm that the fence has been reinstated and the trench remediated? Requested consultant to amend complaints register. Complaint actions on website was incorrect, and now rectified. New process will be adapted to eliminate this issue. Contractor has been engaged and earliest availability is November 2023.
- 3) the complaint on the 4th August 2023 states that a employee knocked down the fence between the mine and his property. However this does not reflect what actually happen, as the fence was destroyed with heavy equipment and a trench dug on the complainant's property directing water into his dam. Can you please confirm this? Amended complaints register. EPA and Resource Regulator visited site to investigate complaint. Water was diverted to dam, failure on our behalf. Contractor did not have correct supervision to carryout task. Once the contractor is back onsite, water will be diverted away from dam. Small section of the fence was manually taken down, again failure on our behalf for not closely monitoring contractor. This section of fencing is scheduled to be replaced.
- 4) in Early August 2023 I made a complaint in regards to water which was entering my property making parts of it inaccessible due to water coming off the mine site however I note this has not been added to the complaints register. The complaint was missed, Amended register to include complaint 3/10/2023.
- 5) following a meeting with an employee of the mine I was informed that I would be contacted the following week after the source of the water was identified. To this date I have not been contacted by the mine and the water is still flowing onto my property. Investigation still being carried out. I was awaiting long period of dry weather to monitor impact of water. Report will be sent once investigation finished. Water was followed on 2 occasions to find source. Preliminary investigations show 3 springs feeding into 1 stream. (MAP)
- 6) on review of the EPL, PA and water management plan, there is one licenced discharge point for mine water. Can you please advise under what licence this water is being discharged through? The watercourse which this water is following is not connect to the licenced discharge point under the mines approvals. Agreed that Invincible mine 1 EPA approved discharge point. A water study will be conducted with the engagement of a hydrologist






Environmental Performance

- Regular environmental monitoring continues across both sites
- Ongoing monitoring of monthly dust and water samples

The following variation has been made to the license:

 The addition of a Pollution Studies and Reduction Program (condition U1) requiring the licensee to undertake an investigation of surface water and groundwater contamination in the vicinity of the Environmental Dam' and develop short, medium and long term management and remediation strategies to redress the low pH water issues.

Hydrologist will need to be engaged for this work






