

# INVINCIBLE COLLIERY Monthly Environmental Monitoring Data for Castlereagh Coal

# 1 INTRODUCTION

Castlereagh Coal owns and operates Invincible Colliery located near Cullen Bullen in the Central West district of New South Wales. # 3 ENVIRONMENTAL PROTECTION LICENCE DETAILS

# 3.1 DEPOSITIONAL DUST

All depositional dust sampling locations were in compliance with the rolling annual average limit (4 g/m $^2$ /month) for the period June 2023 to May 2024. The maximum annual increase in deposited dust levels are also below the criteria limit of 2 g/m $^2$ /month. Depositional dust monitoring results are presented in **Table 1**.

#### 3.2 PM10 AND TSP

The 24-hour maximum  $PM_{10}$  particulate matter concentration less than 10 microns ( $PM_{10}$ ) criterion of  $50\mu g/m^3$  was not exceeded during May 2024. The TSP and  $PM_{10}$  annual rolling average results were calculated with the available data for the period of June 2023 to May 2024. The average values were less than the annual average EPL limit as presented in **Table 2**.

# 4 SURFACE WATER QUALITY

A discharge event is deemed to occur when water leaves the site either through the overflow channel of the Main Dam or as a result of actively pumping water. No discharge occurred from the Main Dam Discharge Point 2 (LD002) during May 2024. A monthly sample was collected



from the Main Dam for due diligence purposes only. Water quality results are presented in **Table 3**.
